Privacy Policy Our Commitment To Your Privacy

The Fredericton Chamber of Commerce has created this Privacy Policy for the Fredericton Chamber of Commerce website and its services to demonstrate our commitment and dedication to the issue of privacy. It is our intent to provide you with the most useful and beneficial online experience while maintaining your privacy. This statement discloses the information practices for this web portal, including what type of information is gathered and tracked, how the information is used, and with whom the information is shared.

This statement and the policies outlined herein are not intended to and do not create any contractual or other legal rights in or on behalf of any party. The Fredericton Chamber of Commerce reserves the right to change this policy at any time and will notify users with a statement on the Fredericton Chamber of Commerce website and/or through regular or email. This Privacy Policy was last revised in October, 2006.

Collection of Personal Information

To register to use the Fredericton Chamber of Commerce portal, the Fredericton Chamber of Commerce requires that members reveal only essential information to properly manage the subscription to the service.

Use of Personal Information

Unless otherwise requested, collected information will be shared on the Fredericton Chamber of Commerce website's membership directory (available to the general public). Only the minimum amount of information required will be collected from members and used solely for these stated purposes. At no time will members be asked for information that is not needed to fulfill a member request, nor will information be sought without a stated explanation.

Changing and Removing Your Personal Information

The Fredericton Chamber of Commerce will use reasonable efforts to allow users to update or correct previously submitted personal information that the user states to be erroneous. Upon a user's request, the Fredericton Chamber of Commerce will use commercially reasonable efforts to functionally delete the user and affiliated personal information from the database. However, it may be impossible to entirely delete a user's entry without some residual information because of backups and records of deletions.

Children's Personal Information

This website is not directed towards nor intended for children. The Fredericton Chamber of Commerce will not knowingly collect or solicit information from anyone under the age of 18.

Third Party Access

The Fredericton Chamber of Commerce does not provide third-party access to any member's personal information except to facilitate that member's own attempts to register or receive offers from selected partners. In our commitment to keeping member information confidential, we will not sell, rent, or lease our mailing lists to third parties, and we will not provide members' personal information to any third party individuals or companies without permission unless required to do so. The Fredericton Chamber of Commerce may be obligated to release personal information when it is believed, in good faith, that such a release is reasonably necessary to comply with the law, enforce the terms and conditions in the portal, or protect the rights, property, or safety of the Fredericton Chamber of Commerce, our users, or others.

Security

The Fredericton Chamber of Commerce is committed to protecting the personal information of our members and has taken measures to avoid the loss, misuse, and alteration of the information under our control. The appropriate physical, technical, and administrative measures have been put in place to protect the quality and integrity of all personally identifiable information.

Cookies

Users should also be aware that non-personal information and data might be automatically collected through the standard operation of Fredericton Chamber of Commerce internet servers or through the use of "cookies." A cookie is an element of data that a website can send to a user's browser, which may then be stored on the user's hard drive or system in order to keep track of usage. As with many other websites, cookies may be used with the Fredericton Chamber of Commerce Website to identify repeat users in order to facilitate such tasks as user ID and password retention. Most web browsers automatically accept cookies but allow users to modify security settings to approve or reject cookies on a case-by-case basis. If a user elects to prevent the use of cookies, one can still access all of the features on the Fredericton Chamber of Commerce website.
